Main Purpose of the Post

As an Educational Psychologist, you will work collaboratively with pupils, parents, educators and other professionals to promote positive educational outcomes and foster a supportive learning environment. You will apply your knowledge of psychological principles, educational assessment and techniques to research and address the various challenges a pupil might encounter.

Requirements of the Role

- An Educational Psychology qualification (e.g. Doctorate or Masters)
- Registration with the HCPC

Required Skills

- the ability to explore emotional issues with children and young people
- a healthy curiosity and research-minded approach to work
- analytical skills
- the ability to be assertive, persuasive and an effective facilitator
- experience monitoring the effectiveness of interventions.

- time management skills to be able to manage a caseload and prioritise your workload
- a flexible and adaptable approach to work, with the ability to use your own initiative

Main Duties

1. Assessment and Evaluation:

Conduct comprehensive assessments to identify and evaluate pupils' cognitive abilities, learning styles, academic skills, emotional well-being and social interactions. Individualised Intervention Planning:

Develop individualised interventions plans based on assessment results and collaborate with teachers, parents and other professionals to implement appropriate strategies.

2. Consultation and Collaboration:

Work closely with teachers, administrators and parents. Attend and collaborate with multi-disciplinary teams to create inclusive learning.

3. Research and Program Evaluation:

Using 'best practice' and keeping up to date with current research to develop research projects and effective educational programmes.

4. Training and Professional Development:

To provide professional development and training sessions on topics such as behaviour management, learning strategies and creating inclusive classrooms.

5. Advocacy and Policy Development:

To be an advocate of the pupil by participating in the development of educational policies and programmes. To collaborate with the policy makers to create a supportive environment that supports positive mental health and academic success.
